

PRIVACY POLICY

Thank you for visiting us at www.retrivika.com (the “Site”). The Site is provided by Tembo Ventures, LLC d/b/a Retrivika (“Retrivika”). Retrivika strongly believes that the protection of privacy is a critical issue when collecting and storing personal information via the internet. We have created this Privacy Policy (this “Privacy Policy”) to inform all visitors to the Site of the measures we employ to keep the information you may choose to share with us private and confidential. We are committed to protecting and safeguarding consumer privacy on the internet. Please carefully review this Privacy Policy before using the Site.

INFORMATION COLLECTED

When you visit this Site, you may provide us with two types of information: (1) personal information you knowingly choose to disclose that is collected on an individual basis, and (2) non-personal information collected by us on an aggregate basis.

Personal information is information that is personally identifiable to you such as your name, email address, mailing address, phone number, date of birth, contact preferences and credit card information. We only gather personal information when it is voluntarily submitted by you. You are not required to disclose any personal information to visit this Site, however you may be required to disclose certain personal information before accessing or using certain features or areas of the Site. We do not collect any personal information about you through this Site without your knowledge.

When you visit this Site we may automatically collect non-personal information such as web site use and activities with respect to your visit, language, zip code, area code, location and other types of non-personal information that does not, on its own, permit direct association with any specific individual. Website use information may include information such as the date and time of your visit, the pages you visited, the address of the website you came from when you came to visit this Site, etc. We may collect, use, transfer, and disclose non-personal information for any purpose. If you do not want us to collect non-personal information then please do not visit or use this Site.

UPDATING, CORRECTING OR DELETING PERSONAL INFORMATION

We strive to provide you with ways to update, correct or delete any personal information that you have submitted to us. When updating, correcting or deleting your personal information, we may ask you to verify your identity before we can act on your request. In order to update, correct or delete your personal information please contact us using the contact information provided on the Site.

Where we can provide information access and correction, we will do so for free, except where it would require a disproportionate effort. We aim to maintain our Site and services in a manner that protects information from accidental or malicious destruction. Because of this, after you

delete, correct or update information, we may not immediately delete, correct or update residual copies from our active servers and may not remove information from our backup systems.

USAGE OF INFORMATION

We recognize and appreciate the importance of responsible use of personal information collected on this Site. The personal information we collect allows us to keep you posted on Retrivika's latest product announcements and updates. We may use your personal information to help us create, develop, operate, deliver and improve our products, services, content and advertising, and for loss prevention and anti-fraud purposes. Retrivika may also from time to time use your personal information to send important notices. We may also use personal information for internal purposes such as auditing, data collection or analysis, and research to improve and enhance our product and service offerings. We may use personal information to enforce any applicable terms of service, to detect, prevent or address fraud or security issues, or to protect against harm. Retrivika may share personal information collected about you with companies affiliated or related to Retrivika such as our subsidiaries and parent companies. Additionally, certain third parties may be engaged by Retrivika to perform a variety of functions. These companies may have access to personal information if necessary to perform such functions. However, these companies may only use such personal information for the purpose of performing these functions and may not use it for any other purpose. We may collect, use, transfer, disclose, and share non-personal information publicly and with our partners or affiliates. For example, we may share information publicly to show trends about the general use of our Site and services. Other than as set forth in this Privacy Policy, we do not sell, transfer, share or disclose personal information to third parties.

USAGE AND COLLECTION OF INFORMATION ABOUT CHILDREN

Our Site is not intended for use by minors. Furthermore, if you are a minor under 13 years old, please do not register or use the Site or our services in any way, or provide any personal information about yourself to us. Retrivika complies with the Children's Online Privacy Protection Act and does not knowingly permit registration or submission of personally identifiable information by anyone less than 13 years of age. If we learn that we have collected the personal information of a child than 13 years of age, we will take steps to delete the information as soon as possible. This age requirement is posted each time we request personally identifiable information.

COOKIES

"Cookies" are pieces of information that a website transfers to an individual's hard drive for record-keeping purposes. Cookies allow websites to remember important information about visitors that make a visitor's use of a website more convenient. Like most web sites, this Site uses cookies and related technologies for a variety of purposes in order to improve your online experience. For example, we may use cookies to determine the number of unique visitors to our Site over a given period and to remember user screen names so that the need for multiple log-ins is eliminated. We do not store any personal information in cookies nor do we link or combine

information collected through cookies to any personal information that users submit when participating in activities on this Site. Cookies cannot be executed as code or deliver viruses.

Use the options in your web browser if you do not wish to receive a cookie or if you wish to set your browser to notify you when you receive a cookie. If you disable all cookies, you may not be able to take advantage of all of the features and activities available on this Site.

We may offer links to sites that are not operated by Retrivika. If you visit one of these linked sites, you should review their privacy policies and all other applicable policies and terms of use. We are not responsible for the policies and practices of other websites, and any information you submit to those websites is subject to their respective privacy policies.

NOTICES AND RESTRICTIONS

We may be forced to disclose certain personal information you submit to us to the government or other law enforcement agencies pursuant to laws, regulations, legal process or governmental requests. We reserve the right to, and by using this Site you authorize us to, use or disclose any personal information or other information we have collected about you as needed or necessary in order to satisfy any law, regulation or legal request, to protect the integrity of this Site, to fulfill your requests, or to cooperate in any law enforcement investigation, for purposes of national security, or other issues of public importance. In the event Retrivika is a party to any merger, acquisition, sale, joint venture, reorganization or other corporate transaction, we may sell, assign, or transfer all personal information to the other party or parties to such transaction without your consent.

OPT-IN/OPT-OUT COMMUNICATIONS

Retrivika may provide you with the opportunity to register for services such as signing-up to receive updates from certain parts of our organization. You are not obligated to register for these services. Also, you can unsubscribe from any electronic communications from us. Please contact us to request that we no longer contact you via e-mail or other means using the personal information you have provided to us.

SECURITY

Retrivika has taken industry reasonable steps to protect the integrity and confidentiality of personal information such as protecting your credit card number when we store your order and whenever we transfer that information to service providers. However, Retrivika cannot guarantee the absolute security of any personal information collected on the Site. It is possible that despite our security measures, others may be able to access or acquire any information that you provide while using the Site. You can do some things to help protect the security of your information. For instance, never give out your password because this is what is used to access all of your account information. Also, remember to sign out of your account and close your browser window when

you finish visiting our Site, so that other people using the same computer will not have access to your information.

YOUR CALIFORNIA PRIVACY RIGHTS
